
# **2022 ANNUAL REPORT**

# Sitting in Idle

Healthcare M&A transaction volume cooled off in 2022 after a record-breaking 2021, as a combination of high inflation, rising interest rates, and global uncertainty caused both buyers and sellers to be more cautious before striking a deal. As those headwinds continued, volume declined in the final three quarters of 2022 to a level not seen since early 2018, excluding the pandemic ravaged second quarter of 2020.

Slowing transaction volume across nearly all industries contributed to private equity and venture capital firms holding a record level of dry powder at the end of 2022 (\$1.96 trillion), up more than 20% from year-end 2021. Given the pressure to put that money to work, investors are still willing to pay premium values for high quality businesses. As illustrated on the final page of this report, valuation multiples for healthcare transactions remained steady in 2022 at 11.6x EBITDA. While valuations varied between sectors, the overall average was in line with the very robust 10-year average of 12.0x.


#### 2022 Providers & Services Transactions

Absent a major economic shock, we expect a cautious "flight to quality" approach to healthcare investing to continue in 2023, resulting in stable but below average transaction volume. We expect the average valuation multiple to also remain stable; but with a greater divergence between the highest-quality assets and those of average or below average quality.

# **Healthcare Transactions by Sector, by Quarter**





## **Physician Practices Sector Profile**


After experiencing record-high activity in 2021, M&A volume in Physician Practices declined nearly 17% in 2022, coming in just below the four-year average of 52 transactions per quarter. Deal activity was spread across many specialties with the more mature PE-backed rollups of Dermatology and Ophthalmology leading the way, joined by the unexpectedly busy Women's/Fertility specialty.

We expect transaction volume to remain stable as economic headwinds moderate the forces driving further consolidation. Practices with leading local market share and strong management teams will continue to command premium valuations even as the overall valuations ease downward.



#### **Behavioral Health Sector Profile**

Behavioral Health transaction volume surged in the second half of 2022 after a slow beginning to the year, with addiction treatment centers continuing to lead the way. Deal activity continues to accelerate in general mental health due in large part to a) health systems seeking to better integrate mental and medical services and b) private equity seeking to consolidate a highly fragmented industry. Interest also remains high in higher margin specialty services such as Autism and Eating Disorders.

We expect Behavioral Health M&A to increase modestly in 2023 with stable valuation multiples.



## **Support Services Profile**

M&A transaction volume in companies who provide Support Services to healthcare providers (e.g., billing, staffing, consulting) had a very strong 2022. Like healthcare generally, these companies are perceived to be recession-resistant, but with lower regulatory and reimbursement risk. In an uncertain economy, employers increasingly look for temporary staffing and outsourced services to fill the employee gap.

Given these factors, we expect investment in Support Services to remain very strong in 2023.



# **Home Health & Hospice Sector Profile**

Home Health public company valuation multiples remained stable in 2022, suggesting the spike from 2018 to 2020 was the anomaly, not the norm. Home Health remains a favorite in the investor community who place a premium on services that lower the total cost of care and are well-positioned to take advantage of long-term demographic trends.

We expect transaction volume and valuations to remain stable in 2023.



#### **Rehabilitation Sector Profile**

Despite a small uptick in public company valuations, Rehabilitation transaction volume decreased from 60 transactions in 2021 to 50 in 2022. Physical Rehabilitation Network, PT Solutions, and ATI Physical Therapy remain among the most active acquirers.

We expect transaction volume to rebound somewhat after a slow Q4, reverting to its long-term average later in the year, but expect valuation multiples to remain stable.



# **Equipment & Supplies Sector Profile**

Companies involved in the manufacture and distribution of medical equipment and supplies accounted for roughly one of every eight healthcare transactions in 2022, with public company valuation multiples also remaining strong despite higher interest rates, increased inflation, and global uncertainty.

We expect transaction volume and valuation multiples to remain strong for the foreseeable future.

#### **Dental Practice Sector Profile**

A strong fourth quarter pushed deal volume in 2022 to its highest level in several years. Private equity-backed DSOs continue to drive transaction volume, capitalizing on the industry's still highly fragmented nature and consumer spending on dental services which is expected to grow at nearly 5% per year through 2025.

We anticipate deal activity and valuations to remain strong, especially among specialty practices such as those offering endodontics.



# **Veterinary Medicine Sector Profile**

According to the ASPCA, more than 23 million households adopted a pet during the pandemic, bolstering already strong investor interest and driving valuation multiples to unprecedented highs. In 2022, Animal Health transaction volume, of which Veterinary Clinics is the largest single component, remained strong but declined 20% from 2021.

While we expect deal activity to remain robust, we also expect valuation multiples for smaller practices to begin declining, perhaps rapidly, later in 2023.

## **Animal Health Transactions by Year**








